ACCOMPLISH YOUR GIVING GOALS

Each type of planned gift has different tax implications. You should always consult a tax attorney or financial planner to understand the personal impact of a propsed gift.



Gifts That Are Payable After Death, Such As a Gift from Will or Trust, or a Beneficiary Designation

- Paid after your passing
- You specify an amount or a percentage of your estate as a bequest in your will or trust
- You may be able to make a larger gift from your estate as a bequest in your will or trust
- You may be able to make a larger gift from your estate than during your lifetime
- Don't forget retirement accounts- they are highly taxed if they go to heirs

Gifts of Appreciated Assets, Such As Stocks or Personal Property

- Given during life or as part of a will or trust
- Gifts of stocks and bonds may help you avoid capital gains taxes and cost less than a cash gift

Gifts That Return Income, Such As a Charitable Gift Annuity

- Given during your lifetime
- Portion of the gift receives an immediate tax deduction
- You receive regular payments during your lifetime, a portion of which may be tax free
- Remainder of the gift is available to your designated charity after death
